2025 will not be achieved. We will fall short by at least Rs 2 lakh crores." "The coronavirus
pandemic could have been an opportunity for India as smartphone manufacturers look for
avenues outside China," says Navkendar Singh, research director of IDC India, a market research
firm. "But these kinds of judgements don't (15) well when it comes to the
ease of doing business."
