R is seated second to the right of T whose house is 10m to the north of the house of the one who works in Himanchal and they both do not work in Uttarakhand. S does not work in Punjab and Telangana state but sits 3rd to the left of the person who works in Uttarakhand whose house is 5m east of S's house. O sits to immediate left of the person who works in Punjab and sits opposite to one who is immediate right of T. M sits 3rd to the left of P and opposite to one who works in Uttarakhand. M's house is 10m to the east of the house of the person who works in Haryana. Houses of R, S and N lies in the same line respectively where R's house is 10m to the West of S's house. The person working in Himanchal sits 3rd to the left of the person who works in Madhya Pradesh. Neither M nor T works in Gujrat and Telangana state. N is not sitting adjacent to the person who works in Uttar Pradesh. P is seated opposite to one who works in Himanchal. The house of the one who is from Telangana. The house of the one from Madhya Pradesh is 20 m east of Q's house.






