Solutions

S1. Ans. (c) Sol. Idioms: Dressing down means give a scolding;

Bone of contention means *cause for quarrel;*

Left-handed compliment means an ambiguous compliment;

House of cards means *an insecure scheme*;

Cuckoo in the nest means an unwelcome intruder;

Words:

Maintained [maintain, verb] means 'cause or enable (a condition or situation) to continue'; Intimated [intimate, verb] means 'state or make known';

Belied [belie, verb] means '(of an appearance) fail to give a true impression of (something)'; Galvanized [galvanize, verb] means 'shock or excite (someone) into taking action';

Among the given options, the idiom '*left-handed compliment*' and the word '*seemed*' provide the correct context to the blanks.

A hint for using the idiom '*left-handed compliment*' in the first blank can be derived from the phrase '*two-handed applause*'.

Hence, option (c) is the correct answer.

Among the given options, the word '*impact*' and the idiom '*beside the mark*' provide the correct context to the blanks. Hence, option (a) is the correct answer.

Among the given options, the word '*distinctive*' and the idiom '*cheek-by-jowl*' provide the correct context to the blanks.

Hence, option (e) is the correct answer.

Sol. Idioms:

Maiden Speech means *first speech*;

A left-handed compliment means an ambiguous compliment;

A cuckoo in the nest means an unwelcome intruder;

Capital punishment means death punishment;

A wild-goose chase means a pointless search;

Words:

Aberration [noun] means 'a departure from what is normal, usual, or expected, typically an unwelcome one';

Calumny [noun] means 'the making of false and defamatory statements about someone in order to damage their reputation; slander';

Acrimony [noun] means 'bitterness or ill feeling';

Deterrent [noun] means 'a thing that discourages or is intended to discourage someone from doing something';

Venality [noun] means 'the condition of being susceptible to bribes or corruption';

The phrase 'rarest of rare cases' suggests that the given sentence is talking about capital punishment and about its effect as a deterrent.

Among the given options, the idiom '*capital punishment*' and the word '*deterrent*' provide the correct context to the blanks.

Hence, option (d) is the correct answer.

Sol. Vindicate [verb] means 'clear (someone) of blame or suspicion';

Enervate [verb] means 'to sap energy from';

The tone and context of the passage suggests that Christian Michel, an alleged middleman, is under the remand of the CBI. Among the given options, the word '*confronted*' provides the correct context to the blank.

Hence, option (e) is the correct answer.

The Central Bureau of Investigation (CBI) on Thursday confronted Christian Michel...

S7. Ans. (c)

Sol. Maintain [verb] means 'to assert';

Castigate [verb] means 'reprimand (someone) severely.';

The context of the clause where the blank appears, and the preceding clause suggest that a series of documents were *obtained* from Italy.

Hence, the option (c) is the correct answer.

...with a series of documents **obtained** from Italy and those gathered as part of the probe since 2013.

S8. Ans. (b)

Sol. Restive [adjective] means 'restless';

Wanting [adjective] means 'lacking';

The context of the sentence where the blank appears suggests that the British High Commission made a request to the CBI, for _____ access to Mr. Michel. A High Commission of a nation would make a request for *consular access* for its national who is in custody with a legal enforcement agency in another nation.

Hence, option (b) is the correct answer.

S9. Ans. (a)

Sol. Abash [verb] means 'make (someone) feel embarrassed, disconcerted, or ashamed'; Ache [verb] means 'suffer from a continuous dull pain';

The sentence previous to the sentence where the blank appears suggests that the CBI had got some deal papers. The clause following the blank '*Mr. Michel allegedly entered into various agreements with AgustaWestland and related entities to help* _____ the contract for supply of 12 helicopters' is the revelation. Among the given options, '**revealed**' provides the correct context to the blank.

Hence, Option (a) is the correct answer.

S10. Ans. (b)

Sol. Alight [verb] means '*descend from a train, bus, or other form of transport*'; The tone of the sentence and the clause where the blank appears suggests that Mr. Michel allegedly entered into various agreements with AgustaWestland to help it to **get** the contract for supply of 12 helicopters.

Among the given words, the word '*clinch*' correctly provides the context to the blank. Hence, option (b) is the correct answer.

S11. Ans. (c)

Sol. corroborate [verb] means 'confirm or give support to (a statement, theory, or finding)'; The context of the sentence suggests that the first priority of the CBI is to get the papers linked to Mr. Michel mentions. Among the given options, the word 'corroborated' provides the correct context to the blank.

Hence, option (c) is the correct answer.

S12. Ans. (e)

Sol. What would an investigating agency do to the other accused persons?

The CBI is currently, as suggested by the context of the paragraph, investigating the case. So, it is likely that the CBI would *summon* the other accused persons. Among the given words, the word '*summon*' provides the correct context to the sentence. Hence, option (e) is the correct answer.

S13. Ans. (b)

Sol. The context of the sentences suggests that the CBI after summoning the other accused persons and witnesses, would make them to *face* Mr. Michel for *verifying the facts*. Among the given options, the word '*confront*' provides the correct context to the blank. Hence, option (b) is the correct answer.

S14. Ans. (c)

Sol. Aberration [noun] means 'a deviation from what is normal or expected'; Acrimony [noun] means 'hatred; ill will';

Calumny [noun] means 'making of a false statement meant to injure a person's reputation'; Venality [noun] means 'the condition of being susceptible to bribes or corruption'; The context of the sentences suggests that the CBI after summoning the other accused persons and witnesses, would make them to *face* Mr. Michel for *verifying the facts*. Among the given options, the word '*verification*' provides the correct context to the blank. Hence, option (c) is the correct answer.

S15. Ans. (a)

Sol. innocuous [adjective] means 'harmless and doesn't produce';

Parsimonious [adjective] means 'extremely frugal; miserly';

Restive [adjective] means 'restless';

Extant [adjective] means 'still in existence';

Among the given options, the word '*allegedly*' provides the correct context to the blank. Hence, option (a) is the correct answer.
