International trade is expected to slow down both internationally and domestically according to a report by the Confederation of Indian Industry. The report titled 'India's Exports: Trends, Challenges and Future Strategy', said _____ (1) to an increase in protectionism across the world, as the ongoing US-China trade war shows. Sol. here, the correct sequence of the parts of sentence will be CADB to make the statement grammatically and contextually meaningful. Also, the error lies in part (D), where "have" will be replaced by 'has'. Hence, option (b) is the most suitable answer choice.

S13. Ans. (e)

Sol. Among the given parts of the sentence, there is no rearrangement required. But, one of the parts, that is part (C), contains a grammatical error where "desirous" will be replaced with "desire". Hence, option (e) is the most suitable answer choice.

Sol. The correct sequence of the given parts of the statement will be DBCA. Also, the error lies in part (B) where "turns" will be replaced by "turned" since the sentence is in past tense. Hence, option (c) is the most suitable answer choice.

Sol. The correct sequence of the given parts of the statement will be **DBAC**. Also, the error lies in part (A), where “**given**” will be replaced with “**give**”. Hence, option (d) is the most suitable answer choice.
