

### Solutions

S1. Ans. (a)

Sol. The correct answer choice is option (a). 1-4 i.e., 'impunity-follow' is the combination of words that will replace each other in order to make the sentence grammatically and contextually correct.

S2. Ans. (b)

Sol. The correct answer choice is option (b). 2-3 i.e., 'radically-determinants' is the combination of words that will replace each other in order to make the sentence grammatically and contextually correct.

S3. Ans. (c)

Sol. The correct answer choice is option (c). 3-1 i.e., 'positions-criticized' is the combination of words that will replace each other in order to make the sentence grammatically and contextually correct.

S4. Ans. (d)

Sol. The correct answer choice is option (d). 1-3 and 2-4 i.e., 'policy-investing' and 'folly-adviser' is the combination of words that will replace each other in order to make the sentence grammatically and contextually correct.

S5. Ans. (a)

Sol. The correct answer choice is option (a). 1-4 and 2-3 i.e., 'defectors-believe' and 'spares-corrupt' is the combination of words that will replace each other in order to make the sentence grammatically and contextually correct.

S6. Ans. (c)

Sol. The positions of the words "investor" and "liability" are incorrect as the appropriate subject for the clause "...if an [subject] is simply moving her money..." is "investor while "tax" is a liability which a person has to pay. Hence swapping the words in the positions (B) and (C) will frame a grammatically correct and contextually meaningful sentence. Therefore, option (c) is the most suitable answer choice.

S7. Ans. (d)

Sol. The positions of the words "lament" and "ensuing" are incorrect. "Lament" means express passionate grief about while "ensuing" means happen or occur afterwards or as a result. Since the bike riding community was hurting, the more appropriate word in the position (C) should be "lament". Hence swapping the words in the positions (A) and (C) will frame a grammatically correct and contextually meaningful sentence. Therefore, option (d) is the most suitable answer choice.

S8. Ans. (b)

Sol. The positions of the words "anchor" and "practices" are incorrect. In the position (B) the more appropriate word is practices as other central banks have inflation-targeting **practices** rather than **anchor**. Moreover, in position (B) after the adjective "inflation-targeting" a noun is required instead of a verb. Hence swapping the words in the positions (B) and (D) will frame a grammatically correct and contextually meaningful sentence. Therefore, option (b) is the most suitable answer choice.

S9. Ans. (c)

Sol. The positions of the words "tribal" - "formation" and "supposed" - "paradigm" should be interchanged as "paradigm shift" is a phrase which means a fundamental change in approach or underlying assumptions while to define the characteristic of population "tribal" is an appropriate word. Hence swapping the words in the positions (A) - (D) and (B) - (C) will frame a grammatically correct and contextually meaningful sentence. Therefore, option (c) is the most suitable answer choice.

S10. Ans. (e)

Sol. All the highlighted words in their original positions are grammatically correct and contextually meaningful and thus successfully form a coherent sentence without interchanging any of the words from their positions. Hence, option (e) is the most viable answer choice.

S11. Ans. (c)

Sol. The positions of the words "land" and "Climate" are incorrect as the phrase 'climate change' and 'land depletion' makes a sense in the sentence. Hence swapping the words in the positions (B) and (C) will frame a grammatically correct and contextually meaningful sentence as "Feeding a hungry planet is growing increasingly difficult as climate change and depletion of land and other resources undermine food systems." Hence option (c) is the most suitable answer choice.

S12. Ans. (d)

Sol. The positions of the words "entities" and "budgetary" are incorrect as the phrase 'budgetary resources' and 'fund-raising through entities' makes a sense in the sentence. Hence swapping the words in the positions

(A) and (C) will frame a grammatically correct and contextually meaningful sentence. Therefore, option (d) is the most suitable answer choice.

S13. Ans. (b)

Sol. The positions of the words “buying” and “salary” are incorrect as the phrase ‘earned a limited buying’ and ‘salary new clothes’ doesn’t add any sense to the sentence. Hence swapping the words in the positions (B) and (D) will frame a grammatically correct and contextually meaningful sentence. Therefore, option (b) is the most suitable answer choice.


S14. Ans. (c)

Sol. The positions of the words “influence” - “pending” and “witness” – “implement” should be interchanged as “witness in criminal” is a phrase which makes a sense similarly “implement a scheme” adds a sense to the sentence. Hence swapping the words in the positions (A) – (D) and (B) – (C) will frame a grammatically correct and contextually meaningful sentence as “Pending legislation by Parliament, the Supreme Court has asked States to implement a scheme framed by the Centre to protect witnesses in criminal trials from threat, intimidation and undue influence.” Therefore, option (c) is the most suitable answer choice.

S15. Ans. (e)

Sol. All the highlighted words in their original positions are grammatically correct and contextually meaningful and thus successfully form a coherent sentence without interchanging any of the words from their positions. Hence, option (e) is the most viable answer choice.
