PAY SCALE:-

The candidates with Postgraduate Medical Degree recognized by the Medical Council of India will be paid **Basic pay Rs.67700/ (Level - 11 and Cell-1)** (Revised) and other usual allowances per month in the first year. (**Total Rs.1,10,000/-**approximately)

ESSENTIAL QUALIFICATIONS:-

A MCI recognized postgraduate Medical degree viz. MD/MS/DNB in the respective discipline from a recognized University/Institute.

Age Limit for appointment as Senior Residents:-

➤ Not exceeding 45 years for General Category

Age is relaxable for Scheduled Caste (SC) & Scheduled Tribe (ST) candidates up to a maximum period of five (5) years & Other Backward Class (OBC) candidates up to a maximum period of three (3) years only if the post is reserved for the respective category.

In case of Persons with Disabilities (PWD's), age relaxation upto a maximum period of ten (10) years for General Category, Thirteen (13) years for OBC category and fifteen (15) years for SC/ST category candidates.

Persons suffering from not less than 40% of relevant disability shall alone be eligible for reservation, fees exemption and age relaxation.

SELECTION PROCEDURE :

1. In case if more number of applications received, then the competent authority may shortlist the candidates for interview. The shortlisting is based on criteria fixed by the competent authority.

In the first instance, all the candidates who fulfill minimum eligibility in respect of age, educational qualifications and experience (wherever required) are short-listed. If this number is high and it is not possible to call all of them for interview, the competent authority further shortlists the candidates on the basis of some suitable shortlisting criteria as may be fixed by the competent authority. Though this may vary from case to case depending on merits, the competent authority generally prefer to call candidates with higher experience in the relevant fields or candidates with higher educational qualification as the case may be.

The purpose of shortlisting candidates is to restrict, to a reasonable limit, the number of candidates to be called for interview keeping in view the number of posts available at a time, the number of candidates satisfying the Essential Qualifications and other conditions prescribed.
