

Sol. India has been placed among the top 10 most affected countries by climate change, in the Global Climate Risk Index 2021 published by the Bonn-based environmental think tank Germanwatch. India ranked as the seventh worst-hit country in terms of climate change in 2019.

Sol. In Uttar Pradesh, a new 3,300-metre-long airstrip has been constructed near Kurebhar on Purvanchal Expressway. With this new airstrip, Uttar Pradesh has become the first state in India having two airstrips on expressways. Uttar Pradesh also has an airstrip on Lucknow-Agra Expressway.
