

Sol. UNESCO: Historic Urban Landscape project launched for Gwalior, Orchha.In the state of Madhya Pradesh, the cities of Orchha and Gwalior have been selected by UNESCO under its 'Historic Urban Landscape Project.' This project was started in the year 2011.

S2. Ans.(a)

Sol. Amsterdam, has unveiled the world's first 3D-printed steel bridge. This project has been opened on the Oudezijds Achterburgwal canal in the city of Amsterdam.
