## <u>CONDUCT OF COMPUTER SKILL TEST FOR THE POST OF UDC AND STENOGRAPHY TEST</u> FOR THE POST OF STENO.

The Phase II - Stenography Test for recruitment to the post of Steno – 2021 and Phase III – Computer Skill Test (CST) for recruitment to the post of UDC-2021 is scheduled to be held on <u>27<sup>th</sup> August</u>, <u>2022 (Saturday)</u> and <u>28<sup>th</sup> August</u>, <u>2022 (Sunday)</u> respectively.

There are some common candidates who are short listed for CST for the post of UDC and Stenography Test for the post of Steno. Some of these candidates have applied for different regions for the post of UDC & Steno.

As the Stenography Test for the post of Steno. and CST for the post of UDC will be conducted on consecutive days i.e. on 27<sup>th</sup> and 28<sup>th</sup> August, 2022 respectively, it has been decided that such common candidates shall be admitted & examined for both the posts in the Region in which they are shortlisted for the post of Steno.

For example, if a candidate 'A' is shortlisted for the post UDC for Madhya Pradesh Region and also shortlisted for the post of Steno. for West Bengal Region, then he/she will be admitted for both the posts at Examination Center in West Bengal Region i.e. the Region in which he/she is shortlisted for the post of Steno.

ESIC will consider the Medium of Computer Skill Test – English or Hindi as filled by the candidate in the Online Application. Those candidates who have opted for Hindi medium in Computer Skill Test are hereby informed that **MANGAL FONT** will be used in the Computer Skill Test in Hindi medium with the option of any of the following two Keyboard Layouts:

- i) **INSCRIPT KEYBOARD** LAYOUT;
- ii) REMINGTON (GAIL) KEYBOARD LAYOUT.

As already notified in the advertisement for recruitment to the post of UDC - 2021, the working knowledge of computers in respect of PWD Candidates who are unable to type shall be assessed by holding an Objective Type Computer Test of 50 Marks having 50 Questions with no negative marking.

### Qualifying Marks in Objective Type Test for PWDs: 15 marks out of Total 50 marks.

As per Govt. of India, Ministry of Social Justice & Empowerment OM F. No. 34-02/2015-DD-III, dated: 29<sup>th</sup> August, 2018 - <u>"the candidate should have the discretion of opting for his own scribe/reader/lab assistant or request the Examination Body for the same."</u>

As per above O.M. dated: 29<sup>th</sup> August, 2018 in case the candidate is allowed to bring his/her own scribe, the qualification of the Scribe should be one step below the qualification of the candidate taking examination.

In case it is found that the qualification of the Scribe brought by the candidate is not one step below the qualification of the candidate taking examination, the candidature of such candidate shall be summarily rejected.

#### STENOGRAPHY TEST FOR THE POST OF STENO. (QUALIFYING IN NATURE)

The candidates who are shortlisted in the Main Examination will be required to appear in the Skill Test of Stenography. The candidates will be given one dictation for 10 minutes in English or Hindi (as opted by the candidates in the Online Application Form) at the speed of 80 words per minute. The matter will have to be transcribed on Computer. The Transcription Time is as under:

#### IMPORTANT INSTRUCTIONS:

- 1. There is no exemption from skill test in Stenography for any category of candidates.
- 2. No PWD Candidate is allowed the scribe facility for any type of assistance in Stenography Test.
- 3. VH Candidate using Braille machine will be allocated workstation at a separate and isolated place.
- 4. ESIC will provide the Computer and Shorthand Notebook for the test; no candidate will be allowed to bring his own key board.
- 5. VH candidates are advised to bring their own Braille Device in case of requirement.
- **6.** ESIC will consider the Medium of Stenography Test English or Hindi as filled by the candidate in the Online Application.
- **7.** The Stenography Test for the post of Stenographer is Qualifying in Nature and the **Qualifying Criteria** in Stenography Tests is as under:
  - Upto 7% mistakes for UR and
  - Upto 10% mistakes for all reserved categories.

## IMPORTANT INSTRUCTIONS TO CANDIDATES REGARDING SUBMISSION OF CERTIFICATES / DOCUMENTS IN SUPPORT OF THEIR ELIGIBILITY FOR THE POST APPLIED FOR

The candidates are required to submit **Self-Attested** copies of the following certificate/documents on the day of Skill Test at the Venue of Skill Test in support of their eligibility for the post as detailed hereunder:

- 1) Matriculation or equivalent certificate in support of proof of Date of Birth,
- 2) Certificates/Mark Sheets etc. in support of Essential Educational Qualification for the post.
- 3) Category Certificate issued by Competent Authority in the prescribed proforma in respect of candidates belonging to SC, ST, OBC, EWS, PWD, Ex-Servicemen and other categories. The prescribed proforma are annexed at Annexure A to Annexure G of the detailed advertisement and are also appended below with this Notice.
  - (a) Candidates seeking reservation benefits available for SC/ST/OBC/EWS/PWD/Ex-Servicemen must ensure that they are entitled to such reservation as per eligibility prescribed in the detailed advertisement and as per the instructions issued by Govt. of India. They should also be in possession of the certificates in the prescribed format of Govt. of India in support of their claim.
  - (b) Candidates claiming reservation/ age relaxation under OBC Category should possess the OBC Certificate as given at Annexure -"A" prescribed vide Govt. of India, Department of Personal and Training OM No. 36012/22/93-Estt.(SCT) dated 15.11.93 along with Self Declaration to be given at later stage as given at Annexure "B" failing which the benefit of reservation or age relaxation will not be given.
  - (c) Candidates claiming reservation under EWS Category should submit the EWS Certificate given at Annexure -"C".
  - (d) Candidates claiming relaxation/reservation under Ex-servicemen Category should submit form of undertaking as given at Annexure -"D".
  - (e) ESIC Employees/Government Servants claiming age relaxation shall have to produce a certificate in the prescribed format annexed at 'E' from their office in respect of the length of continuous service which should be not less than three years in the immediate period preceding the closing date for receipt of application. They should continue to have the status of ESIC Employee/Government Servants till the time of appointment, in the event of their selection.
  - (f) Ex-Servicemen who have already secured employment in civil side under Government in Group 'C' & 'D' posts on regular basis after availing of the benefits of reservation given to ex-servicemen for their re-employment are NOT eligible for claiming benefits of reservation under Ex-Servicemen category. However, they are eligible for age relaxation only. The period of "Call up Service" of an Ex-Serviceman in the Armed Forces shall also be treated as service rendered in the Armed Forces for purpose of age relaxation. For any serviceman of the three Armed Forces of the Union to be treated as Ex-Serviceman for the purpose of securing the benefits of reservation, he must have already acquired, at the relevant time of submitting his application for the Post / Service, the status of ex-serviceman and /or is in a position to establish his acquired entitlement by documentary evidence from the competent authority that he would complete specified term of engagement with the Armed Forces within the stipulated period of one year from the Closing Date, or otherwise than by way of dismissal or discharge on account of misconduct or inefficiency. Serving Defence Personnel shall have to produce certificate issued by the competent authority in the Performa given annexed at 'F'.
  - (g) PWD candidates other than in the category of blindness, locomotor disability (both arm affected-BA) and cerebral palsy, who have availed services of scribe in the Phase I and/or Phase II Exam(s) are required to submit certificate regarding physical limitation to write in the prescribed proforma appended at Annexure G of the detailed advertisement and appended below with this Notice.
- 4) Two passport size photograph which should match the one uploaded in the online application form.
- 5) **Photo bearing Identification Proof** (self-attested photocopy **along with Original thereof**) The candidates are required to bring at least one currently valid Photo identity proof in original and a photocopy of the same.
