INTRODUCTION

This Booklet gives you detailed information about the competitive examination for recruitment of Probationary Officers in State Bank of India. This post was advertised on the Bank's website https://bank.sbi/careers/current-openings and https://www.sbi.co.in/careers/current-openings. The terms and conditions, period of probation, emoluments etc. were given in the advertisement No. CRPD/PO/2024-25/22. You should ensure that you are eligible in respect of age, educational qualification, nationality etc. as stipulated in the advertisement.

This handout contains details pertaining to various aspects of the online Main examination you are going to take and describes the kind of test which will be given to you in the examination. **The examination will be conducted online.** You are advised to study this booklet carefully as it will help you in preparing for the examination.

GENERAL INSTRUCTIONS

- Particulars to be Noted: Please note carefully your Roll Number, Date of Exam, Reporting time and venue for the examination given in the call letter.
- 2. Punctuality in Attendance: You must report at the examination venue as per the time mentioned on Call Letter. Late comers will not be allowed to take the test.
- 3. Call Letter: Affix firmly your recent passport size photograph in the space provided for it in the call letter for Online Main Examination and bring it with you along with photo identity proof in original and a photocopy when you come to the venue for the examination. Call letter for Online Preliminary Examination and copy of photo identity proof, which was authenticated/stamped by exam officials at the time of Online Preliminary Examination, is also to be brought. You will not be permitted to appear for the examination if you come without the photo identity proof in original and a photocopy, Call letter of Online Main Examination with your photograph affixed thereon, call letter of Online Preliminary Exam and copy of photo identity proof, which was authenticated/stamped by exam officials during Preliminary Examination. You will be required to sign on your call letter and affix your left thumb impression in the space provided for candidate's signature and thumb impression respectively in the presence of the invigilator in the examination hall. You must bring your own stamp pad for affixing your thumb impression. Signature in CAPITAL LETTERS will not be accepted. You should submit both your call letters along with the photocopy of photo identity proof at the end of the examination.
- 4. Candidates who are eligible for and want to use services of scribe are required to submit a Declaration Form (Scribe Declaration Form) along with the Call letters. This can be downloaded from Bank's website.
- 5. For candidates availing scribe in accordance with OM F. No. 29-6/2019-DD-III dated 10.08.2022, shall be allowed scribe facility subject to production of a certificate at the time of online examination to the effect that person concerned has limitation to write and that scribe is essential to write examination on his/her behalf from competent medical authority of a Government healthcare institution as per Appendix I and Appendix II of the said guidelines. Such candidates shall not be allowed to appear for the examination without the specified medical certificate as per Appendix I of the said guidelines. The qualification of the scribe should be one step below the qualification of the candidate taking the examination and the candidate appearing for the exam should submit details of the scribe as per Proforma at Appendix-II of the said O.M.
- 6. During the exam, at any stage, if it is found that scribe is independently answering/ solving the questions himself/ herself, the exam session for such candidates will be terminated, and candidate's candidature will be cancelled. The candidature of such candidates using the services of a scribe will also be cancelled if it is reported/ detected after the examination by the test administrator personnel that the scribe independently answered the questions.
- 7. Compliance with Instructions: You should scrupulously follow the instructions given by test administrators and the invigilators at all the stages of the examination for which you have been called. If you violate the instructions, you will be disqualified and may also be asked to leave the examination hall.
- 8. Use of Books, Notes, Calculators & Cell Phones: No calculator separate or with watch, cell phones, books, smart watch, slide rulers, notebooks or written notes will be allowed inside the examination hall.
- **9.** Do not leave your seat unless you are allowed.

- **10. Use of Stationery:** You must bring stationery such as pencils, ball point pen, eraser, blue ink stamp pad with you.
- 11. Rough work to be done on the sheet provided: You should do all the necessary rough work on sheets provided only. After the test is over, you should submit the rough sheets to the Invigilator. You must write your Name, Roll Number, Registration Number and Date of examination on every rough sheet used by you. Any candidate who does not return the above material or is found to attempt to take or pass on the questions or answers inside or outside the examination hall will be disqualified and the Bank may take further action against him as per rules of the Bank.
- 12. There will be Penalty for wrong answers marked by you in the objective tests. There are five alternatives answers to every question of all the tests. For each question for which a wrong answer has been given by you, one-fourth of the marks assigned to that question will be deducted as penalty. If a question is left blank, i.e. no answer is given by you, there will be no penalty for that question. If the total of the penalty for test is in fraction, it will be rounded off to the nearest integer. You should therefore be careful in marking your answers.
- 13. Copying / Misconduct / Unfair Practices: If a candidate is/has been found guilty of -
 - Copying or allowing copying;
 - ii) Using unfair means during the test;
 - iii) Impersonating or procuring impersonation by any person;
 - iv) Misbehaving at the examination venue;
 - v) Disclosing, publishing reproducing, transmitting, storing or facilitating transmission and storage of test contents in any form or any information therein in whole or part thereof or by any means verbal or written, electronic or mechanical or taking away the papers supplied in the examination hall or found to be in unauthorised possession of test content.
 - vi) Resorting to any other irregular or improper means;
 - vii) Obtaining support of his/her candidature by any means.
 - He/she will, in addition to rendering himself/herself liable to criminal prosecution, be liable to,
 - (a) Disqualification from selection process.
 - (b) Be debarred permanently/for specific period from any examination or selection by the Bank.

Candidates are warned against filling up/furnishing false, tampered/fabricated information or suppressing material information.

The Bank would be analyzing the responses of a candidate with other appeared candidates to detect patterns of similarity. On the basis of such an analysis, if it is found that the responses have been shared and scores obtained are not genuine/valid, the Bank reserves the right to cancel his/her candidature.

- 14. Candidate must submit the following documents before leaving Lab/Venue:
 - Call letters (Preliminary and Mains examination)
 - Photocopy of photo ID proof
 - Rough Sheets
 - Scribe Declaration (if applicable)
- 15. Travelling Allowance shall not be paid: No travelling allowance or other expenses in connection with the examination will be paid.
- 16. The possibility for occurrences of some problem in the administration of the examination cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be

made to rectify such problem, which may include movement of the candidates from one venue/lab/computer (node) to others and reconduct of the examination if considered necessary.

17. Following items will not be allowed inside the examination hall (Lab) :-

Any stationery item like textual material (printed or written), bits of papers, Geometry/Pencil Box, Plastic Pouch, Calculator, Scale, Writing Pad, Pen Drives, Log Table, Electronic Pen/Scanner, any communication device like Mobile Phone, Bluetooth, Earphones, Microphone, Pager, Health Band etc. Other items like Goggles, Handbags, Hair-pin, Hair-band, Belt, Cap, any watch/Wrist Watch, Camera, any metallic item, any eatable item opened or packed, water bottle (only transparent water bottle is allowed), Any other item which could be used for unfair means for hiding communication devices like mobile phone, camera, bluetooth devices etc.

You are advised to avoid wearing ornaments like Ring, Earrings, Nose-pin, Chain/Necklace, Pendants, Badge, brooch etc.

- 18. Any canvassing for selection including change of date, time and venue shall be considered as disqualification.
- 19. Candidates are advised to take note of "The Public Examinations (Prevention of Unfair Means) Act, 2024".
- 20. Candidate Registration:

At the venue, Candidate registration will be done through photo capture and IRIS Scan (Biometric capture of Right thumb impression for VI candidates). Photo captured will be matched with the photo uploaded by the candidate in the application.

IRIS Scan

IRIS will be scanned at the examination venue. Refusal to participate in the process of IRIS scanning on any occasion may lead to cancellation of candidature. With regards to the same, please note the following:

- (a) 'LEFT EYE (IRIS)' will be captured for all the candidates.
- (b) Candidates should remove Contact Lenses and Spectacles while capturing IRIS. Candidates are advised to avoid wearing contact lenses and prefer spectacles.

For VI candidates, Biometric capture of right thumb impression will be done. If fingers are coated (stamped ink/mehndi/coloured...etc.), ensure to thoroughly wash them so that coating is completely removed before the examination day. (Any failure to observe these points will result in non-admittance for the examination).

The candidates will be permitted to move out in an orderly manner one candidate at a time. Please wait for instructions from invigilator and do not get up from your seat until advised.

PHASE II: MAIN EXAMINATION

Main Examination will be conducted online and will consist of Objective Tests for 200 marks and Descriptive Test for 50 marks. The Descriptive Test will be administered immediately after conclusion of the Objective Test and candidates will have to type their Descriptive Test answers on the computer.

(i) Objective Test: The duration of objective test is 3 hours and it consists of 4 Sections of total 200 marks. There will be separate timing for every section.

SECTIONAL CUT OFF / MINIMUM QUALIFYING MARKS IN MAIN EXAMINATION:

- ♦ Each candidate will have to score a minimum sectional score in each test (i.e. Objective type paper I, II, III, IV & Descriptive type paper individually) in Main Examination.
- Depending on the number of vacancies available, sectional cut offs will be decided by the Bank.

Selection Criteria for Phase-III: Category wise merit list will be drawn on the basis of the aggregate marks scored in Phase-II (Main Exam). Candidates numbering up to 3 times (approx.) of the category wise vacancies will be shortlisted for Phase-III from the top of the category wise merit list subject to a candidate scoring the minimum aggregate qualifying score, as decided by the Bank.

Penalty for Wrong Answers:

There will be penalty for wrong answers marked in Objective Tests. For each question for which a wrong answer has been given by the candidate, 1/4th of marks assigned to that question will be deducted as penalty to arrive at corrected score. If a question is left blank, i.e. if no answer is marked by candidate, there will be no penalty for that question.

Phase III Comprise of : (a) PSYCHOMETRIC TEST (b) GROUP EXERCISE (c) PERSONAL INTERVIEW

(a) **PSYCHOMETRIC TEST**: The Bank will conduct Psychometric test for personality profiling, of those candidates who will be shortlisted for Phase-III. Finding of the test may be placed before the Interview panel for having a through perspective on the candidates.

The minimum qualifying marks for group exercise & Interview will be decided by the Bank.

Final Selection:

The candidates will have to qualify both in Phase-II and Phase-III separately. The marks obtained in Main Examination (Phase-II), both in the Objective Test and the Descriptive Test, will be added to the marks obtained in Phase-III for preparing the final merit list. The marks obtained in the Preliminary Examination (Phase-I) will not be added for preparing the final merit list for selection.

The marks obtained by the candidates in Phase-II (Main Examination both Objective & Descriptive Tests) and Phase-III (Group Exercise & Interview) will be normalized to 100 marks as detailed below.

The final merit list is arrived at after aggregating (out of 100) converted marks of Phase-II and Phase-III. Selection will be made from the top merit ranked candidates in each category.

DETAILS OF THE ONLINE EXAMINATION PATTERN (OBJECTIVE)

- 1. A login screen will be displayed to the candidate. The candidate has to log in using his/her User ID and Password which is provided on the call letter.
- 2. After logging in Candidate's profile (Name, Roll No & photograph etc.) will be displayed and the candidate has to confirm the same by clicking on 'I confirm' button confirming the profile is correct.
- 3. Thereafter the instructions will be displayed on the screen.
- 4. Candidate should read the instructions carefully and indicate that he/she has done so by 'checking' (click) the box at the bottom of the screen, after which 'I am ready to begin' button is activated.
- 5. After clicking on the 'I am ready to begin' button the actual test time will begin.

In addition, there will be questions based on passage, to test your comprehension.

- 6. In Online Main Examination there will be 155 questions and each question is followed by 5 alternatives/ options.
- 7. The questions except those on English Language will be available in Hindi & English. In order to view a given question in other language, a candidate can click on the 'view in' drop down box and select the desired language.
- 8. Only one question will be displayed at a time.
- 9. Total duration of objective examination is 180 minutes (separate timing for each section).
- 10. Compensatory time of 20 minutes for each 60 minutes will be allowed for candidate with disability eligible for compensatory time.
- 11. In order to answer a question, candidate has to 'mouse click' the option he/she thinks appropriate/ correct. The alternative which has been clicked on will be highlighted and shall be treated as the answer given by the candidate for the question.
- 12. After selecting an answer for a question candidate should click on the 'SAVE & NEXT' button to save his answer and proceed to the next question. Note that without clicking on 'SAVE & NEXT' button the answer selected will not be saved.
- 13. Note that only questions for which answers are saved or marked for review after answering will be considered for evaluation.

- 14. In case a candidate does not wish to attempt the question then he/she should not click on any option for that question. A candidate can choose to deselect his/her answer for a particular question by clicking on the 'CLEAR RESPONSE' button provided against each question.
- 15. In case a candidate wants to skip a particular question and return to it later in a particular section, he/she can do so during the timing prescribed for that section.
- 16. The question numbers of attempted and unattempted questions are also shown to the right of the screen. A candidate can then click on any of the question number to view the question, in order to attempt/ revise his/her answer to the question.
- 17. Each section has separate timing. A candidate can navigate between questions within a section during time prescribed for that section by clicking on the question number displayed to the right of the screen.
- 18. The Question Palette displayed on the right side of screen will show the status of each question using one of the following symbols:
 - You have not visited the question yet.
 - You have not answered the question.
 - You have answered the question.
 - You have NOT answered the question, but have marked the question for review.
 - The question(s) "Answered and Marked for Review" will be considered for evaluation.

The Marked for Review status for a question simply indicates that you would like to look at that question again. If a question is answered and Marked for Review, your answer for that question will be considered in the evaluation.

- 19. Under no circumstances should a candidate click on any of the 'Keyboard keys' once the exam starts as this will lock the exam.
- 20. The clock will be set at the server. The countdown timer in the top right corner of screen will display the remaining time available for you to complete the examination. When the timer reaches zero, the examination will end by itself.

Submitting the exam:

- 21. A candidate can change his/ her answer for a question in a section within the time prescribed for that section.
- 22. After the expiry of time the candidates will not be able to attempt any question or check their answers. On completion of test time, answers of the candidates would be saved automatically by the computer system even if they have not clicked the "Submit" button.
- 23. Please note that a candidate will not be allowed to "finally submit" unless they have exhausted the actual test time of the examination.

DETAILS ABOUT DESCRIPTIVE PAPER

- Immediately after online objective test, Descriptive Paper will be administered online.
- 2. Candidates will have to answer Descriptive Paper by typing on the computer.
- 3. Candidates are allowed to use key board to type their answers.
- 4. Spellcheck facility will not be available for candidates.
- Candidates can submit their answer papers after completion of test time i.e. 30 minutes only.
