### Operation Olivia: A Marine Conservation Success by the Indian Coast Guard

In a major boost to marine conservation, the Indian Coast Guard (ICG), through its annual mission Operation Olivia, has successfully protected nearly 6.98 lakh Olive Ridley turtles that nested at the Rushikulya river mouth in Odisha in February 2025. The operation underscores India's commitment to preserving marine biodiversity by ensuring safe nesting habitats for this vulnerable species during its annual breeding season.

#### Why in News?

The Indian Coast Guard announced on May 19, 2025, that its initiative Operation Olivia had recorded the protection of 6.98 lakh Olive Ridley turtles during the nesting season at the Rushikulya river mouth in Odisha. This marks a record achievement in marine conservation under the initiative.

#### Aim and Objective

- **Primary Goal:** To ensure safe nesting of Olive Ridley turtles by minimizing threats such as illegal fishing and habitat destruction.
- Promote community participation, NGO collaboration, and the use of sustainable fishing tools like Turtle Excluder Devices (TEDs).

#### Background and Implementation

- Launched in the early 1980s, Operation Olivia is conducted annually from November to May.
- Focuses on nesting beaches in Gahirmatha, Rushikulya river mouth, and other coastal Odisha regions—key breeding grounds for the Olive Ridley turtle.

#### Key Achievements in 2025 Season

- Protected 6.98 lakh Olive Ridley turtles at Rushikulya river mouth in February 2025.
- Over 5,387 surface patrol sorties and 1,768 aerial surveillance missions conducted since inception.
- Detained 366 boats involved in illegal fishing activities.
- Established MoUs with NGOs for conservation and education programs.



### Community and Tech Initiatives

- Promoted Turtle Excluder Devices (TEDs) among local fishermen.
- Supported sustainable practices and raised awareness through community engagement.
- Collaborated with states like Karnataka to begin geo-tagging turtles to monitor movement.

#### Significance

### Mizoram Becomes India's First Fully Literate State

In a historic milestone for education in India, Mizoram has officially been declared a fully literate state, becoming the first in the country to achieve this feat. The announcement was made on 20<sup>th</sup> May 2025 by Chief Minister Shri Lalduhoma during a special ceremony in Aizawl, in the presence of key central and state dignitaries. This achievement highlights the state's dedication to inclusive education and marks the success of the ULLAS – Nav Bharat Saaksharta Karyakram, a national adult education initiative.

#### Why in News?

Mizoram was recently declared India's first fully literate state under the New India Literacy Programme (NILP). This recognition comes after extensive surveys, teaching efforts, and community participation to educate all remaining non-literate individuals in the state. The announcement coincides with growing national efforts to implement the NEP 2020 vision of achieving universal literacy.

### Centre Launches e-Zero FIR to Fast-Track Cybercrime Cases

In a significant push toward combating cybercrime, the Ministry of Home Affairs (MHA) has launched a new initiative called e-Zero FIR under its Indian Cyber Crime Coordination Centre (I4C). The move, announced by Union Home Minister Amit Shah on May 20, 2025, aims to enable swift registration of FIRs in high-value cyber financial fraud cases. Currently launched as a pilot project in Delhi, the system will automatically convert complaints filed via the National Cybercrime Reporting Portal (NCRP) or helpline 1930 into Zero FIRs for cases involving losses above ₹10 lakh—significantly enhancing the response time in apprehending cybercriminals.

### Why in News?

The e-Zero FIR initiative was launched recently by the Ministry of Home Affairs to fast-track investigations in cyber financial crimes. It is initially being implemented in Delhi and is expected to be extended across India soon.

### Aim & Objectives

- **Aim:** To ensure faster registration and investigation of cyber financial crimes.
- **Objective:** Streamline the process of converting high-value cyber fraud complaints into FIRs to catch cybercriminals quickly.

### Background

- With a rapid increase in online financial frauds, the government saw a pressing need to accelerate the FIR registration process.
- Traditionally, complaints lodged via the NCRP or helpline took time to be converted into FIRs due to multiple verification steps.

### Key Features

The e-Zero FIR system will,

- Automatically register Zero FIRs for financial cybercrime complaints above ₹10 lakh.

Accept complaints through,

- National Cybercrime Reporting Portal (www.cybercrime.gov.in)
- Helpline number 1930
- Route the Zero FIRs to the concerned cyber crime police stations.
- Require complainants to visit the cybercrime PS within 3 days to convert Zero FIR into a regular FIR.

### Static Facts

- **Zero FIR:** An FIR that can be filed at any police station, irrespective of the jurisdiction, and later transferred to the appropriate PS.
- **I4C (Indian Cyber Crime Coordination Centre):** A division under the Ministry of Home Affairs, launched in 2020, to deal with cybercrime in a coordinated manner.
- **1930:** Helpline number for financial cyber fraud complaints in India.

### Overall Significance

- Improves accountability and transparency in cybercrime handling.
- Ensures faster investigative response and real-time coordination between agencies.
- Boosts public trust in the government's cyber safety infrastructure.
- Aims to build a cyber-secure India, as emphasized by Amit Shah.

### WHO Adopts First-Ever Global Pandemic Treaty

In a landmark development, the World Health Organization (WHO) adopted the world's first global pandemic treaty during its annual World Health Assembly in Geneva on May 20, 2025. The agreement, passed by a vote of 124 in favor, none against, and 11 abstentions, aims to create a more equitable and coordinated global health response to future pandemics. The absence of the United States — a former WHO member — raises concerns about implementation and funding.

### Why in News?

On May 20, 2025, WHO member states voted to adopt the first global pandemic treaty. It comes after three years of negotiations since the devastating impact of COVID-19. The treaty marks a major milestone in global health governance, even as the United States remains absent, having withdrawn from WHO earlier in 2025.

### Aim and Objectives

- Ensure equitable access to diagnostics, vaccines, and therapeutics.
- Strengthen international coordination and global health infrastructure.
- Promote One Health approach, recognizing the interconnectedness of human, animal, and plant health.
- Establish a system for pathogen access and benefit sharing.
- Encourage geographically diverse R&D and local manufacturing.
- Facilitate technology and knowledge transfer.

### Key Highlights

- **Voting Outcome:** 124 countries supported the treaty; 11 abstained; none opposed.
- **No External Control:** The treaty respects national sovereignty — WHO cannot mandate lockdowns or vaccination rules.
- **Financial Mechanism:** A new fund will support pandemic response preparedness globally.
- **Equity Focus:** Responds to COVID-era inequality, where richer countries hoarded medical resources.

### Background

- The idea was mooted during the second special session of the World Health Assembly in December 2021, following the second COVID wave.
- Drafting was led by the Intergovernmental Negotiation Body (INB) over 13 rounds of meetings.
- The final draft was completed in April 2025.

### Significance

- Ensures the world is better prepared for future pandemics.
- Demonstrates the power of multilateral collaboration in global crises.
- Highlights a shift from reactive to proactive health policy at the global level.
- The treaty is a public health victory, addressing global inequity in healthcare.

### PM Modi Inaugurates 103 Amrit Stations Across 18 States Under ₹1,100 Crore Plan

On May 22, 2025, Prime Minister Narendra Modi inaugurated 103 redeveloped Amrit Stations across 86 districts in 18 states, marking a major milestone under the Amrit Bharat Station Scheme. Developed at a cost of over ₹1,100 crore, these modernized stations aim to transform the passenger experience by enhancing comfort, connectivity, and convenience while celebrating India's rich cultural and architectural heritage. This initiative is part of a broader national effort to modernize over 1,300 railway stations and uplift infrastructure in line with India's growing transit needs.

### Why in News?

On May 22, 2025, Prime Minister Narendra Modi inaugurated 103 redeveloped Amrit Stations located in 86 districts across 18 states as part of the Amrit Bharat Station Scheme. The project was completed at a cost of over ₹1,100 crore. This marks a significant milestone in modernizing India's railway infrastructure while celebrating regional architecture and cultural heritage.

### Key Objectives and Aims

- To modernize railway stations with world-class infrastructure.
- To improve passenger amenities with a focus on Divyangjan-friendly facilities.
- To preserve and highlight regional architectural styles and cultural heritage.
- To ensure sustainability and energy efficiency in station design.

**Supreme Court Mandates Three Years of Legal Practice for Judicial Service Entry**

In a landmark judgment delivered on May 20, 2025, the Supreme Court of India mandated a minimum of three years of legal practice as a prerequisite for applying to the Civil Judge (Junior Division) post. The ruling, led by a bench headed by Chief Justice of India B.R. Gavai, aims to enhance the quality of the judiciary by ensuring that candidates have hands-on experience in litigation before assuming judicial roles.

**Why in News?**

The decision is significant because it restores a legal practice requirement that had been waived by several High Courts, allowing fresh law graduates with no courtroom experience to become judges. The Supreme Court found this practice ineffective over the past two decades and deemed it detrimental to judicial efficiency and public trust.

**Background**

- Earlier, several High Courts permitted direct recruitment of fresh law graduates into the judiciary.
- The SC reviewed affidavits submitted by High Courts, which reported negative outcomes of appointing inexperienced candidates.

**Key Judgments and Directions**

- All High Courts and State Governments must amend service rules.
- Minimum three years of practice as an advocate is now mandatory for applying to the Civil Judge (Junior Division) post.
- The period of practice will be counted from the date of provisional enrollment with the Bar Council.

**Certification Requirements**

Candidates must provide proof of practice certified by,

- Principal Judicial Officer of the court, or
- Advocate with at least 10 years' experience, endorsed by a judicial officer.

**Additional Considerations**

- Experience as a law clerk to a judge or judicial officer will be counted toward the three-year requirement.
- The rule will apply to future recruitment cycles only and not those already underway.

**Objectives and Significance**

- Ensures that newly appointed judges have practical exposure to court proceedings.
- Strengthens the judiciary by appointing officers who understand the realities of litigation.
- Aims to reduce errors and inefficiencies stemming from inexperience.

**Gujarat's Lion Population Grows by 32% Since 2020**

In a landmark development for wildlife conservation in India, the Gujarat Forest Department has reported a 32% increase in the Asiatic lion population over the last five years, reaching 891 lions in 2025. This positive trend reflects the success of ongoing conservation efforts and habitat management under initiatives like Project Lion. However, the expanding lion territory now includes non-forested and human-populated areas, raising concerns about human-wildlife conflict.

**Why in News?**

On May 21, 2025, the Gujarat Forest Department released the 16th Asiatic Lion Census, highlighting a 32% increase in population since 2020. The update is significant as it underscores both conservation success and emerging challenges, particularly in human-wildlife coexistence. This follows the approval of Project Lion by PM Modi in March 2025, with a ₹2,900 crore outlay to improve lion habitats.

**Background & Conservation Success**

- The Asiatic lion (*Panthera leo persica*) is found only in India, primarily in Gir National Park and its surroundings.
- From 2020 to 2025, lion numbers rose from 674 to 891, a 32% jump.
- Adult females increased to 330, a 27% rise, indicating strong future growth potential.

**Expansion of Territory**

- Lion range increased by 16.67% from 30,000 sq. km in 2020 to 35,000 sq. km in 2025.
- Over 50% of lions now live outside protected areas, entering 11 districts of Saurashtra, including coastal and non-forested zones.

**New Satellite Populations**

Satellite populations include 497 lions across 9 regions such as,

- Barda Wildlife Sanctuary
- Jetpur region
- Babra-Jasdan belt
- Mityala Wildlife Sanctuary (doubled to 32 lions)
- 22 lions now recorded in a corridor area for the first time.

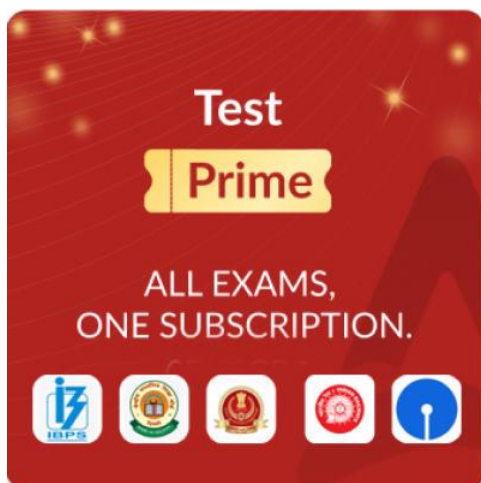


### Challenges and Human-Lion Conflicts

- Increasing encounters with humans
- 10% annual rise in livestock attacks across villages.
- 15% annual rise in livestock killed per village.
- Despite this, 61% of locals remain tolerant, but experts stress sustainable land-sharing strategies.

### National Affairs

- The **Archaeological Survey of India (ASI)** has restored the historic **Rajon Ki Baoli**, a **16th-century stepwell** from the **Lodi era**, located in **Mehrauli**, Delhi. 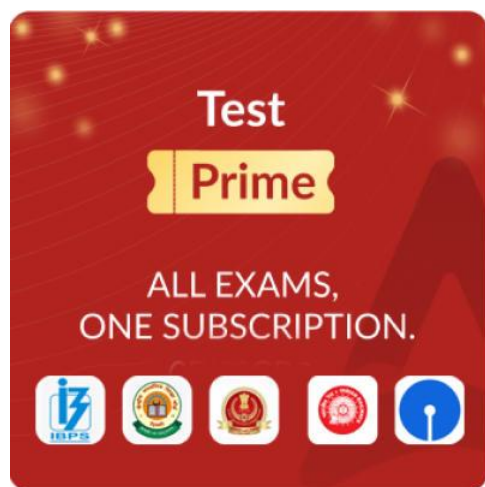
