RECRUITMENT OF ZONE BASED OFFICERS IN JUNIOR MANAGEMENT GRADE SCALE I IN MAINSTREAM ON REGULAR BASIS - DECLARATION OF RESULT

Attention is invited to notification dated 29.04.2025 as per which interviews for 266 vacancies of Zone Based Officer in JMG Scale I in Mainstream was conducted by Bank from 05.05.2025 to 09.05.2025.

We are now pleased to declare the list of candidates provisionally shortlisted for the post of Zone Based Officer in JMG Scale I in Mainstream.

Candidates enlisted in Annexure A-1 who couldn't produce 10th or 12th standard mark sheet/ certificate evidencing having studied the specified opted local language of the applied Zone as one of the subjects, have to undergo the test of knowledge of specified opted local language of the applied Zone.

The Language Proficiency test for such candidates shall be conducted in Mysuru (Karnataka) tentatively on 24.07.2025. Link for downloading call letters for Language Proficiency test for the post of Zone Based Officer (Mainstream) along with schedule shall be circulated through a separate Notification.

Biometric/ iris verification of the candidates will be conducted at the time of Language Proficiency test.

The issuance of offer of appointment to the candidates is subject to clearance of Language Proficiency test. Candidates have to present for language proficiency test on schedule date and place and have to qualify the Language Proficiency test, failing which, they will not be considered for issuing offer of appointment and their candidature shall be cancelled/rejected.

Candidates are advised to carry original as well as photocopy of the KYC Documents (PAN, Adhar, Passport, Driving License etc.) along with 2 recent passport size colour photographs to the centre at the time of Language Proficiency test for verification by Bank officials.

No Travelling Allowance is payable to candidates who are called for Language Proficiency Test. However, unemployed SC/ST/PWBD Candidates, who are called for Language Proficiency Test, will be paid actual expenses incurred, subject to their claiming, to and fro 2nd Class Rail (Non-AC)/Ordinary Bus fare in terms of Govt. guidelines by the shortest route on production of evidence of travel, i.e. Railway Receipt/Ticket(s) for attending the Language Proficiency Test. They shall not be entitled to any reimbursement of boarding / lodging charges incurred by them for attending the Language Proficiency Test.

Candidates are advised once again to check if they are fulfilling eligibility criteria as per notification in all respects. Bank reserves the right to disqualify any candidate who does not fulfil the eligibility criteria at any point of time.

It is reiterated that candidates should regularly visit the Bank's website for updates/ notices/ instructions. All announcements/addendum/ corrigendum/ details pertaining to this process will be only published / provided on authorized Bank's website www.centralbankofindia.co.in from time to time under Career section.

No separate communication/ intimation will be sent to the candidates who are not selected/ shortlisted in the process. All notification/ communication placed on Banks's website shall be treated as intimation to all candidates who have applied for the process.

The Bank reserves the right to reject any application/ candidature at any stage or cancel the conduct of test or to cancel the recruitment process entirely at any stage without assigning any reason.

Decision of the Bank in respect of all matters pertaining to this recruitment would be final and binding on all candidates.
