The lingering COVID-19 crisis is a good time to **revive** an issue that is, oddly, slow to come to life in India — universal health care (UHC). Meanwhile, UHC has become a well-accepted objective of public policy around the world. It has even been largely realised in many countries, not only the richer ones (minus the United States) but also a growing number of other countries such as Brazil, China, Sri Lanka and Thailand. Some of them, such as Thailand, made a decisive move towards UHC at a time (20 years ago) when their per capita GDP was no higher than India's per capita GDP today. The time has come for India — or some Indian States at least — to take the plunge.

The basic idea of UHC is that no one should be deprived of quality health care for the lack of ability to pay. This idea was well expressed — in archaic words perhaps — by Aneurin Bevan, the fiery founder of the National Health Service (NHS) in Britain. "No society," he said, "can legitimately call itself civilised if a sick person is denied medical aid because of lack of means." The same idea inspired the Bhore Committee report of 1946, where a case was made for India to create its own NHS-type health-care system.

In concrete terms, UHC typically relies on one or both of two basic approaches: public service and social insurance. In the first approach, health care is provided as a free public service, just like the services of a fire brigade or public library. If this sounds like socialist thinking, that is what it is. Interestingly, however, this socialist project has worked not only in communist countries such as Cuba but also in the capitalist world (well beyond the United Kingdom). The second approach allows private as well as public provision of health care, but the costs are mostly borne by the social insurance fund(s), not the patient, so the result is similar: everyone has access to quality health care. Social insurance is very different from a private insurance market. The simplest variant is one where insurance is **compulsory** and universal, financed mainly from general taxation, and run by a single non-profit agency in the public interest. That is how it works in Canada (province-wise), and to varying extents in other countries with "national health insurance" (e.g., Australia and Taiwan).

India's recovery varies widely across sectors and manufacturing remains troubled due to weak demand and increasing input costs. This is borne out by the latest industrial output data.

The World Bank's prognostications about India's growth prospects seem more sanguine than some others. The Asian Development Bank expects India's GDP for the year to rise 7.5% with retail inflation of around 5.8%. Monetary and fiscal policy mandarins need to address inflation more aggressively, lest it derails the recovery which the Bank has warned could renew pressure on improving bank and corporate balance sheets. One of the key objectives of reforms has been to reduce the distortions generated by the earlier **excessive** micromanagement of the economy. With internal economic liberalisation, openness to international trade, and investment, an open free market economy has emerged. Improving the ease of doing business continues to be a major priority. But even more important is the cost of doing business. For this, action is needed to reduce government policy-induced pricing distortions which add to the cost of doing business. Melatonin is a naturally occurring hormone controlled by light exposure that helps regulate your sleepwake cycle. Your brain secretes more melatonin when it's dark—making you sleepy—and less when it's light—making you more alert. However, many aspects of modern life can alter your body's production of melatonin and shift your circadian rhythm. Eating lots of sugar and refined carbs such as white bread, white rice, and pasta during the day can trigger wakefulness at night and pull you out of the deep, restorative stages of sleep. You might be surprised to know that caffeine can cause sleep problems up to ten to twelve hours after drinking it. Similarly, smoking is another stimulant that can disrupt your sleep, especially if you smoke close to bedtime. Avoid big meals at night.

Residual stress, worry, and anger from your day can make it very difficult to sleep well. Taking steps to **manage** your overall stress levels and learning how to curb the worry habit can make it easier to unwind at night. The planet's biodiversity is under threat and the main culprit is the one who, paradoxically, depends on it most: human beings. Pollinators are essential in plant reproduction, guaranteeing our food production. Plants and oceans act as major carbon sinks. In short, biodiversity provides us with clean air, fresh water, good quality soil and crop pollination. It helps us fight climate change and adapt to it as well as reduce the impact of natural hazards. Since living organisms interact in dynamic ecosystems, the disappearance of one species can have a far-reaching impact on the food chain. It is impossible to know exactly what the consequences of mass extinctions would be for humans, but we do know that for now the diversity of nature allows us to thrive. Protecting biodiversity is a very complex task because most of humanity's actions have a negative effect on ecosystems by weakening them. For instance, human activities generate pollution that affects living species. Deforestation destroys the habitat of many animals, insects, and plants. Our agriculture favors certain productions neglecting others and leading to the destruction of certain ecosystems like tropical forests and species like orangutans. In order to protect biodiversity, it would, therefore, be necessary to change our economic model of consumption to minimize our impact on the natural environment.





Trying to save the whole planet is a lofty goal, but it's not something you can do alone. Plastic pollution is most visible in developing Asian and African nations, where garbage collection systems are often inefficient or nonexistent. But the developed world, especially in countries with <u>low recycling rates</u>, also has trouble properly collecting discarded plastics. Plastic trash has become so **ubiquitous** it has prompted efforts to <u>write a global treaty</u> negotiated by the United Nations.

Plastics made from fossil fuels are just over a century old. Production and development of thousands of new plastic products accelerated after World War II, so transforming the modern age that life without plastics would be unrecognizable today. Plastics revolutionized medicine with life-saving devices, made space travel possible, lightened cars and jets—saving fuel and pollution—and saved lives with helmets, incubators, and equipment for clean drinking water.

The conveniences plastics offer, however, led to a throw-away culture that reveals the material's dark side: today, single-use plastics account for 40 percent of the plastic produced every year. Many of these products, such as <u>plastic bags</u> and food wrappers, have a lifespan of mere minutes to hours, yet they may persist in the environment for hundreds of years.

Most of the plastic trash in the oceans, Earth's last sink, flows from land. **Trash** is also carried to sea by <u>major rivers</u>, which act as conveyor belts, picking up more and more trash as they move downstream. Once at sea, much of the plastic trash remains in coastal waters. But once caught up in ocean currents, it can be transported around the world.





Once at sea, sunlight, wind, and wave action break down plastic waste into small particles, often less than one-fifth of an inch across. These so-called microplastics are spread throughout the water column and have been found in every corner of the globe, from Mount Everest, the highest peak, to the Mariana Trench, the deepest trough.

Microplastics are breaking down further into smaller and smaller pieces. Plastic microfibers, meanwhile, have been found in municipal drinking water systems and drifting through the air.

Millions of animals are killed by plastics every year, from birds to fish to other marine organisms. Nearly 700 species, including endangered ones, are known to have been affected by plastics. Nearly every species of seabird eats plastics.

Most of the deaths to animals are caused by entanglement or starvation. Seals, whales, turtles, and other animals are strangled by abandoned fishing gear or discarded six-pack rings. Microplastics have been found in more than 100 aquatic species, including fish, shrimp, and mussels destined for our dinner plates. In many cases, these tiny bits pass through the digestive system and are expelled without consequence. But plastics have also been found to have blocked digestive tracts or pierced organs, causing death. Stomachs so packed with plastics reduce the urge to eat, causing starvation.

Plastics have been consumed by land-based animals, including elephants, hyenas, zebras, tigers, camels, cattle, and other large mammals, in some cases causing death.

Thus, option (a) is the correct answer, as it gives the only incorrect statement.
