





- 4. As per advertisement in cases where more than one candidate secures equal aggregate marks, tie has been resolved by applying the method i.e. Date of Birth, with older candidate placed higher.
- 5. The horizontal reservation cuts across the vertical reservation (which is called interlocking reservation) and the category who have been provisionally recommended for selection against the PwBD quota have been placed in their appropriate category viz. SC/ST/OBC/EWS/UR depending upon the category to which they belong in the roster meant for reservation SC/ST/OBC and EWS by making necessary adjustment in the same category of quota, as per DoPT/Govt. of India rules.

- 6. Mere inclusion of the name of the candidate in the list of provisionally eligible candidates in the result notice does not confer any right upon the candidate over the post unless the Board is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 7. The provisional selection of above candidates shall be further subject to genuineness of the documents on the basis of which he/she has claimed to have fulfilled all the eligibility conditions as prescribed in the Recruitment Rules and terms and conditions of advertisement inviting applications and subject to thorough verification of his/her identity with reference to their photographs, signatures/handwriting etc. in the application form, admission certificate etc.
- 8. The candidature of the candidate is liable to be cancelled by CBSE, in case, candidate is found not fulfilling the eligibility conditions of the Recruitment Rules for the post or for any other grounds for disqualifications.
- 9. The decision of CBSE regarding eligibility of the candidate shall be final and binding on the candidates. The Competent Authority of CBSE shall issue the offer of appointment to the candidates separately after being satisfied about their eligibility as laid down in the recruitment rules and terms and conditions of detailed advertisement dated 31.12.2024.
