**Subject: Modification in Educational Qualification Criteria for the Recruitment to the Post of Assistant Manager (Officer Grade A) - 2025 in International Financial Services Centres Authority**

This is for information of all concerned that in terms of clause VIII (9) of the vacancy notification the educational qualification criteria mentioned in the **advertisement dated 10.09.2025** for the recruitment to the post of Officer Grade A (Assistant Manager) in IFSCA, stands modified as below:-

- (a) The educational qualification as specified for General Stream under Clause I (5) of the said advertisement may be read as under:

<b>Stream</b>	<b>Educational Qualification (As on 25.09.2025)</b>
General	Master's Degree with specialization in Statistics/ Economics/ Commerce/ Business Administration (Finance) / Econometrics. or Bachelor's degree in Information Technology/ Computer Science/ Master's in Computer Application/ Information Technology. or Bachelor's degree in commerce with CA, CFA, CS and ICWA. or Bachelor's degree in Law or in any other discipline from a recognized University.

- (b) The “Note” below Table under Clause I (5) i.e.-

**“Note:** *Candidates must have obtained a minimum of 60% marks or equivalent grade in the respective qualifying examination, i.e., Masters or Bachelors Degree, in order to be eligible to apply.”*

stands deleted.

- (c) Furthermore, point (i) under “Note IV” of Clause I (7) i.e.-

**“In case of candidates belonging to SC/ST categories, relaxation in educational standards to the extent of 5% marks is allowed at Bachelor’s Degree/Master’s Degree”**

stands deleted, as it has become redundant in light of point 1(b) of this corrigendum.

2. The registration link will be modified shortly incorporating the above-mentioned changes.
3. All other terms and conditions of the original advertisement dated 10.09.2025 shall remain unchanged.
4. In case of any clause/terms and conditions in the original advertisement are in contravention of these modified conditions, these modifications shall prevail.
