Given that sleeves can make or break a garment, it's surprising that there isn't much India-specific information available on the ________ of what, designer Neeta Lulla calls, "one of the pillars of a piece of clothing". In her career of 40 years, Lulla has worked as a costume designer for about 400 films, from Lamhe (1991) to Devdas (2002) and Thalaivii (2021). Sleeves are what "haldi (turmeric) and dhaniya (coriander)" are to food, she says. "When it comes to the evolution of sleeves in India, much of the influence has come from the West," says Lulla. "Traditionally, we mostly had slim sleeves with motifs and symbols." Why is sleeve mania in vogue? "Fashion moves in a cyclical way so we are seeing all kinds of sleeves right now," replies Lulla. "But you can't forget their functional aspect." In fashion, nothing is ever just fashion. Each aspect of a garment serves a purpose. In many versions of the abaya, for example, the sleeves are comfortably bell shaped so the outfit becomes more airy. "Traditionally, European clothes had a strong presence of heavy cuffs and power shoulders to provide protection from the weather," Rimple offers another example.

During the 1500s and 1600s, puff sleeves became famous because of their "cosmetic" use. "The Elizabethan and Victorian eras saw the emergence of puff sleeves. Women would wear corsets to get tiny waists, and when big sleeves were added, they made the person look even smaller and achieve that perfect hourglass shape. Then you had the Edwardian sleeves that were romantic with ruffles and lace," explains Lulla. She explains how she used three-quarter, puff sleeves in the romance-drama Lamhe to give Sridevi's character Pallavi a soft, feminine and youthful look. "This (the Renaissance period) was the time when women's fashion, especially sleeves, was at the forefront."

The same puff sleeves became a trend in 1950s India when the country's cinema was taking shape, hence influencing popular culture. "India had recently gained independence from Britain and the presence of Edwardian sleeves was everywhere, especially in Kolkata (since it had been one of the leading cities in British times)," says Lulla, who has been studying sleeves for decades.

- **(e)** Incorrect: The Chinese zodiac framework does not **derive its structure solely from constellations**; it combines animals with the five elements, which is not a characteristic of Western astrology, which uses the zodiac signs and planets more directly.

Thus, **(c)** is the correct answer.

Other options either contradict data trends or overestimate the mitigating effects of technology and investment.

S31. Ans.(b)

Sol. Statements (I) and (II) are correct.

- (I) is correct as the passage mentions "encouraging older citizens to remain in the workforce" and "adopting robotics and AI" as strategies.
- (II) is correct as the government is investing in "childcare subsidies, parental leave policies, and family support programs."

- **(c) Historical focus on industrial growth:** The passage does not suggest that industrial growth has stabilized or influenced population trends directly.
- **(d) Unrelated to historical factors:** This contradicts the entire premise of demographic trends being the result of historical patterns.
- **(e) Historical increases in fertility rates:** The passage emphasizes declining birth rates, not an increase in fertility. Thus, this is not supported by the data.

It also implies that nuclear power plays an important role in achieving these rapid reductions.

(e) is the incorrect interpretation because the phrase "which calls for rapid cuts in emissions" emphasizes the need for quick, decisive actions, not slow progress. The passage stresses the urgency of the transition to low-carbon energy to meet climate goals.

(d) The passage implies that nuclear power helps meet the rapid emission reduction requirements.

- o This is a correct interpretation. The passage suggests that nuclear power is a crucial component in achieving the rapid reduction in CO2 emissions, as it complements other low-carbon sources like renewables.
- (e) The phrase indicates that slow progress in emission reductions is acceptable.
- o This is the **incorrect** interpretation. The phrase explicitly states the need for "rapid" cuts in emissions, which contradicts the idea that slow progress would be acceptable. The entire passage emphasizes the urgency of reducing emissions, making this option wrong.

- (c) is incorrect because the passage suggests that energy costs will rise as a result of the decline in nuclear power. Nuclear power helps maintain cost stability in energy supplies, and its reduction would lead to higher costs, especially as investments in alternative sources like renewables increase.
- (d) is the **correct** answer because the passage directly states that the decline of nuclear power has serious implications for electricity security and the cost of energy. Without nuclear power, which provides a stable and low-carbon energy source, electricity security is compromised, and the transition to alternative sources like renewables would become more expensive.

(e) is incorrect because while the passage suggests that there would be a need for increased investments in renewable energy to replace nuclear power, it does not state that advanced economies would revert to using more fossil fuels. The focus is on the need for low-carbon alternatives, not a return to carbon intensive sources.

Statement (III) is incorrect because the passage does not suggest that **perovskite solar cells** have achieved higher efficiency than traditional photovoltaic panels. It highlights their affordability and versatility, but not higher efficiency.
