Note 1:- The number of vacancies may be increased or decreased without any notice, depending upon the number of vacancies as on date of preparation of merit list and posting. However, number of candidates to be recommended will be decided by the High Court.

Note 2:- The benefit of relaxation in age, fee and reservation will not be extended to the applicants of reserved categories of other states (except age relaxation to Government employees as provided in Rules). These applicants are required to apply under General category in Online Application Form.

Note 3:- The reservation for different categories and related matters will be regulated as per the provisions of The Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Service) Rules, 1997 as amended from time to time and other guidelines/instructions issued by Haryana Government which are duly adopted by the High Court for the employees working in the Subordinate Courts of Haryana State.

(In case sufficient/required number of candidates are not available in any of the respective reserved category, then the vacancies left unfilled in such reserved category may be filled by the High Court from amongst the candidates available in unreserved category, subject to their availability, in terms of Explanation to Rule 7 of the Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Service) Rules, 1997.)

Note 4:- Applicant opting "Others" in Gender column in Online Application Form must hold a certificate of identity issued by the District Magistrate under section 5 of "The Transgender Persons (Protection of Rights) Act 2019 which deals with "Application for certificate of identity" read with section 6 of the Transgender Persons (Protection of Rights) Act, 2019 which deals with the "Issue of certificate of identity". Such applicants can avail the benefits of reservation subject to completion of all other formalities/conditions in said regard.

Note 5:- In the light of the provision contained in Chapter VI, Section 33 of "The Rights of Persons with Disabilities Act, 2016" the High Court has adopted the Notification No. 38-16/2020-DD-III dated 04.01.2021 of the Government of India for the purpose of identification of suitable category of Benchmark Disabilities for the posts of Clerk to be filled by way of direct recruitment in the Subordinate Courts of Haryana.

Note 6:- Reservation for Freedom Fighters of Haryana and their children/grand children will be available only if quota reserved for Ex-servicemen or Backward Classes remains unfilled to that extent due to non-availability of suitable Ex-servicemen or their dependents or non-availability of suitable candidates from Backward Classes. Over all reservation either from the unfilled vacancies of Ex-servicemen or from the Backward Classes for Freedom Fighters/their children/grand children will remain limited to 2% only. This benefit will be available to all grand children i.e. sons and daughters of sons and daughters (paternal as well as maternal) of the Freedom Fighters.

Note-I:- For appointment of an ex-serviceman, his age will be calculated keeping in view the actual age minus (actual period of military service plus upto three years of break, if any, between military and civil service). If the resultant age does not exceed the maximum age limit, including the number of years of any other relaxation in age admissible to him, prescribed for the post for which he is seeking appointment he shall be deemed to satisfy the condition regarding age limit.

Note-II:- The upper age limit of an applicant of any category (except Ex-servicemen) shall not exceed 52 years who is entitled to avail the benefit of relaxation in age of one or more of the categories mentioned above.

Note-III:- The experience certificate(s) of equivalent post issued by the Appointing Authority of respective Department/Board/Corporation/Government-aided Institutions only shall be valid.

2. **QUALIFICATION:-**

The applicant should possess a degree of Bachelor of Arts or Bachelor of Science or equivalent thereto from a recognized university and have proficiency in computers (Word Processing and Spread Sheets).

In addition to the above, applicant should have passed matriculation with Hindi or Sanskrit as one of the subject or should have done +2/B.A./M.A. with Hindi as one of the subject, before the cut-off date of qualification (as mentioned below).

The applicant should fulfill the condition of qualification on the last date of receipt of application i.e. 23/06/2026 (closing date for submission of online applications).

3. **DISQUALIFICATION:-**

No Person :-

- a) Who has entered into or contracted a marriage with a person having a spouse living or;
- b) Who, having a spouse living has entered into or contracted a marriage with any person.

Shall be eligible for appointment to the service.

Provided that the Hon'ble High Court, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage may exempt any person from the operation of this rule.

4. **PAY AND ALLOWANCES:-**

The salary, pay and allowances etc. of the recommended candidates will be governed as per the latest rules and instructions issued by the Government of Haryana and duly adopted for the Subordinate Courts of Haryana from time to time.

5. **NATIONALITY, DOMICILE & CHARACTER OF PERSONS:-**

As per Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Service) Rules, 1997.

6. **FOR REGULAR GOVERNMENT EMPLOYEE:-**

The applicants, who are in the service of the Punjab/Haryana Government, other State Government or the Government of India, High Court, Subordinate Courts & Union Territory, Chandigarh, while applying, should obtain No Objection Certificate from their Head of Office or Department, and keep it with them. If applicants fail to produce the No Objection Certificate as and when called for, their candidature will stand cancelled.

7. **FOR PERSONS WHO HAVE ALREADY WORKED OR PRESENTLY WORKING ON ADHOC/CONTRACT/WORK-CHARGED/DAILY WAGES BASIS IN ANY DEPARTMENT/BOARD/ CORPORATION OF HARYANA GOVERNMENT INCLUDING GOVERNMENT-AIDED INSTITUTIONS UNDER HARYANA GOVERNMENT.**

Candidates availing the benefit of age relaxation shall have to submit their experience certificate(s) of equivalent post issued by Appointing Authority of respective Department/Board/Corporation/Government-aided Institutions in original as and when demanded, failing which their candidature will stand cancelled.

Note:- The application fee for applicant opting “Others” in Gender column shall be applicable as per their category in above mentioned table.

9. **SPECIAL INSTRUCTIONS:-**

The decision of the High Court in all matters relating to acceptance or rejection of an application, eligibility/suitability of the applicants, mode/criteria for selection etc. shall be final and binding on the applicants. The High Court may shortlist the candidates at any stage of the recruitment process on the basis of some criteria. No inquiry or correspondence shall be entertained in this regard.

The particulars mentioned/ information given in the Online Application Form will be treated as final. Candidates will have to produce testimonials in support of given particulars/information. Failure to produce supportive testimonial(s) and/or to substantiate particulars/ information will lead to rejection of candidature. No variation in this regard will be either accepted or allowed to be explained.

10. **E-ADMIT CARDS & DEMO TEST:-** E-Admit Cards of provisionally eligible applicants will be uploaded on the website. Applicants will also receive E-mail/SMS in this regard. The applicants can download and get print out of their E-Admit Cards by visiting the website www.sssc.gov.in again by entering their registration ID and password. **Admit Cards shall not be sent by post.** Mere issuance of provisional E-Admit Card does not imply that applicant has fulfilled all the eligibility conditions given in the advertisement and application is subject to subsequent scrutiny and the application can be rejected, if the applicant is found to be not fulfilling the eligibility conditions at any point of time.

The applicants shall paste their photograph, duly attested by a **Gazetted Officer/Self attested**, on the E-Admit Card. The photograph must be same as uploaded by the applicants in their Online Application Form. In case of non-matching of photograph with the uploaded

photograph, applicant will not be allowed to enter the examination centre and no request in this regard will be entertained in any circumstances at that time or anytime later.

A link of Demo/mock test to enable the candidates to familiarize with the online test will also be uploaded on the website of S.S.S.C. 15 days prior to the date of examination.

Applicants are advised to visit the website of S.S.S.C. i.e. www.sssc.gov.in and check their E-Mail accounts (inbox as well as spam box) regularly for updates and important information. Un-necessary correspondence with S.S.S.C. should be avoided.

11. TEST CENTRES AND DATE OF EXAMINATION:-

Examination can be conducted anywhere in Northern India on any suitable date(s). The date(s) of examination will be notified on the official website of S.S.S.C. (www.sssc.gov.in) only and candidates are advised to regularly visit the official website S.S.S.C. The decision of Competent Authority with regard to allotment of Test centre, date of examination and shift, if any shall be final and no request for change in Test centre/city, date of examination and shift will be entertained.

12. MODE OF SELECTION:-

The applicant shall have to take online written examination (Computer Based Test) in the following subjects: -

Note:- *‘Marks’ means normalized marks in objective portion (Refer to page No. 8 for details in normalization of marks) and actual marks in subjective portion.

It is clarified that there will be negative marking in multiple choice questions. For every wrong answer, 1/4th mark will be deducted. The question(s) not attempted will receive no credit or discredit. Furthermore, candidates shall have to type subjective part examination of English Composition on computer within the stipulated time period. English composition (Subjective) will be checked only of those candidates who will secure 33% or more marks in General Knowledge.

Thereafter, out of total candidates who qualify the written examination (Computer Based Test), the number of candidates (category wise) as decided by the High Court will be called for Computer Proficiency Test (CPT) i.e. to assess the proficiency of candidates in operation of computer, which is mandatory, however, the marks of this Computer Proficiency Test would not be counted in determining the final merit as this test is only of qualifying nature. Computer Proficiency Test shall comprise of two parts. In Part-I, Candidates will have to qualify the

Spread Sheet Test which is of 10 marks and of 10 minutes duration by securing 40% or more i.e. 4 or more marks. In Part-II, candidates will have to qualify Computer Typing Test in English at the speed of 30 W.P.M. Typing Speed will be calculated by using the following formula:-

Note: Part-II i.e. Word Processing Test will be checked only of those candidates who will secure 4 or more marks in Spread Sheet Test (Part-I).

Persons with Benchmark Disability in the category of locomotor disability (Both Arm Affected-BA) can submit their application for exemption from Computer Proficiency Test along with Disability Certificate while Persons with benchmark disability as defined in Section 2(r) of the Rights of Persons with Disabilities Act, 2016 can submit their application for exemption from Computer Proficiency Test along with Disability Certificate as well as Medical Certificate to the effect that the person concerned has physical limitation to type at the requisite speed i.e. 30 W.P.M., from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government healthcare institution and Persons with disability as defined in Section 2(s) of the Rights of Persons with Disabilities Act, 2016 can submit their application for exemption from Computer Proficiency Test along with Medical Certificate to the effect that the person concerned has physical limitation to type at the requisite speed i.e. 30 W.P.M., from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government healthcare institution, within 15 days from declaration of result of Written Examination (Computer Based Test).

The candidates shall be exempted from Computer Proficiency Test by the Competent Authority. The decision of the Competent Authority shall be final and binding upon the candidate.

The number of candidates (category wise) as decided by the High Court, who qualify both the tests i.e. written examination (Computer Based Test) as well as Computer Proficiency Test (CPT), will be called for checking of original testimonials/interaction.

Thereafter, Select List of the qualified candidates will be prepared strictly on the basis of merit in online written examination i.e. Computer Based Test (CBT). Name of candidate(s) higher in merit [i.e. those who secured higher marks in Written Examination (Computer Based Test)] would be recommended for appointment as per the number of vacancies to be filled. In case, if two or more candidates have obtained same marks, then the candidate elder in age among the same scorers will be kept higher in merit. Still further, in case, any such even scoring candidates are having the same date of birth, then they be placed alphabetically (A-Z) in the concerned merit list.

ANSWER KEY AND SEEKING OF OBJECTIONS/CROSS OBJECTIONS

After the completion of the written examination (Computer Based Test), provisional Answer Key shall be provided to the candidates on the official website of S.S.S.C. i.e. www.sssc.gov.in. Candidates will be given opportunity to raise objections to the Answer Key. A nominal non-refundable fee of ₹25/-per objection will be charged. Candidates will also be given opportunity to file cross-objection against the proposed changes in the provisional answer key.

Candidate must mention the proposed correct answer and objection/cross-objection must be supported by appropriate reasons and documentary proof thereof, failing which such objection/cross-objections will not be considered. Objections/cross-objections received after

stipulated time period and those filed on any other medium other than the prescribed link will not be considered.

NORMALIZATION OF MARKS

If written examination (Computer Based Test) is held in multiple shifts, normalization of scores of objective portion shall be carried out using the below mentioned Standard Deviation Method (calculation of marks will be up to 5 decimals places):-

Normalization marks of j^{th} candidate in i^{th} session \hat{M}_{ij} is given by:

M_{ij} = is the actual marks obtained by the j^{th} candidate in the i^{th} Session.

\bar{M}_t^g = is the average marks of the top 0.1% of the candidates considering all sessions.

M_q^g = is the sum of mean and standard deviation marks of the candidates in the paper considering all sessions.

\bar{M}_{ti} = is the average marks of the top 0.1% of the candidates in the i^{th} session or marks of topper if session strength is less than 1000.

M_{iq} = is the sum of mean marks and standard deviation of the i^{th} session.

M_q^{gm} = is the sum of mean marks of the candidates in the shift having maximum mean and standard deviation of marks of candidates in the examination considering all shifts.

13. IMPORTANT INSTRUCTIONS:-

(i) Applicants **are advised to visit** the website of S.S.S.C. and check their E-mail accounts (inbox as well as spam box) regularly for updates regarding Examination, Result and other important information. **Unnecessary** correspondence with S.S.S.C. should be **avoided**.

(ii) All applicants irrespective of their category i.e. General or reserved category, can submit **only one application** for a particular category. In case, an applicant submits more than one application, only latest application will be **considered**.

(iii) All other conditions of recruitment not covered in the above **Notice shall be regulated as per The Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Services) Rules, 1997 as amended from time to time**.

(iv) Employees of Subordinate Courts of Haryana are governed by Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Services) Rules, 1997 and Haryana Civil Services Rules, 2016.

(v) Merely satisfying the **eligibility criteria does not entitle** the applicant to be called for examination. High Court reserves the **right to alter/modify or change in any** of the terms and conditions including selection criteria etc. spelt out in the advertisement.

(vi) The benefit of reservation under any category will be given only to those candidates who are bonafide resident of Haryana State and possess certificates issued by the Competent Authority of Government of Haryana and submit the application against reserved category posts. The said certificates must be **latest** and valid as on closing date for submission of online application form i.e. **23/06/2026**. The criteria for exclusion of persons within the Backward Classes as Creamy Layer shall be as per Haryana Govt. Notification No. 40/13/2024-1SW dated 16.07.2024.

Further, candidates belonging to BC category would be required to submit an undertaking (as and when required) along with the BC certificate that no change occurred in their status and they do not fall in the section of creamy-layer up to the closing date for submission of online application form.

(vii) The reservation for Economically Weaker Sections of Haryana will be given as per instructions of the Haryana Government bearing Letter Nos. 22/12/2019-1GSIII dated 25.02.2019 and 22/12/2019-1GSIII dated 13.03.2019. They must possess latest Income & Assets Certificate on prescribed proforma as per instructions of the Haryana Government bearing Letter Nos. 22/12/2019-1GSIII dated 13.03.2019 which should be valid for the Year 2026-2027 based on gross annual income for the Financial Year 2025-2026 issued on or before the closing date of application form. EWS certificate issued for jobs in Central Govt. will not be considered irrespective of income mentioned in certificate.

(viii) Reservation for Ex-servicemen and his family members (son, daughter or spouse) will be governed in accordance with instructions contained in letter Nos.12/15/2019-4GS-II dated 09.03.2022 and 12/15/2019-4GS-II dated 13.04.2022 of Government of Haryana.

ESM candidates must possess Identity Card issued by concerned Zila Sainik Board or Discharge certificate/Book. Disabled ESM/Family member (Son, Daughter or Spouse) of Disabled ESM must have disability certificate & proof that he/his/her father or husband has not been released in the normal course after the completion of his/her term or retired from military service voluntarily and family member of Martyr shall produce relevant certificate/Battle Casualty certificate which proves the Martyr status issued by Competent Authority.

Family member (Son, Daughter or Spouse) of Disabled ESM/ESM candidates of Haryana claiming benefit must have valid eligibility certificate from the concerned Zila Sainik Board on last date of submission of online application form.

Competent Authority can direct the ESM candidates to provide relevant information along with the affidavit to avail the benefits.

(ix) The Reservation for **Eligible Sports Person of Haryana** shall be governed by instructions of the Haryana Government bearing Letter Nos. 22/10/2013-1GSIII dated 15.07.2014, 22/10/2013-1GSIII dated 27.03.2017, 718 SW(1) 2017 dated 13.07.2017, 22/10/2013-1GSIII dated 06.04.2018, 22/10/2013-1GSIII dated 06.04.2018, Memo no. 4/40/2017-4SYA dated 18.05.2018 and 22/10/2013-1GSIII dated 06.06.2018.

(x) The Reservation for **Freedom Fighter of Haryana and their children/grand-children will be governed by** instructions of the Haryana Government bearing Letter Nos. 22/10/2013-1GSIII dated 15.07.2014. Children/Grand Children of Freedom Fighter must have Certificate duly issued by the respective Competent Authority.

(xi) The reservation for the **Persons with Benchmark Disabilities of Haryana** shall be governed as per the instructions/guidelines of Haryana Government bearing letter Nos. 22/10/2013-1GSIII dated 17/19.04.2017, 22/10/2013-1GSIII dated 25.04.2018, 22/43/2018-1GSIII dated 26.04.2018, 22/106/2018-1GSIII dated 01.05.2019, Notification Endst. No. 459-SW(4)/2021 dated 25.10.2021 and letter No. 22/59/2020/1GS-III dated 25.03.2022.

(xii) Persons with Benchmark Disabilities with only those category(ies) of disability(ies) mentioned in vacancy position of this Employment Notice shall be eligible to apply for the

posts under PwBD category. Therefore, concerned candidates are advised to read it carefully before applying.

(xiii) Persons with Benchmark Disabilities (PwBD) can also apply, even if the post is not reserved for them, provided the post has been identified as suitable for persons with disabilities of the relevant category. However, such candidates will be considered for selection to such post by general standard of merit and without any relaxed standards.

(xiv) The admission of applicants at all stages of the recruitment process will be **purely provisional** and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary proof in support thereof. If on verification at any stage before or after the said process and even after the completion of selection process, it is found that an applicant does not fulfill any of the eligibility condition, the candidature of such applicant shall **stand cancelled** without any **further notice and with consequential effect**.

(xxvii) Computer Based Test/Examination is a format for the Written Examination, where the candidates would be required to attempt the question papers on a computer. Therefore, the participating candidates should note that the examination may be conducted on different dates for different sets of candidates.

(xxviii) All communications addressed to S.S.S.C should invariably contains the following particulars:-

- (i) Advertisement No. & Name of Post.
- (ii) Registration ID.
- (iii) Roll No. (if received)
- (iv) Name of Candidate (in Full and Block Letters)
- (v) Registered E-Mail.

(xxix) Re-evaluation of answer sheets is not allowed. Only re-checking of answer sheets (i.e. no part of the answer sheets has been left unevaluated or there is no totalling error) can be allowed on a written request from a candidate addressed to the Member Secretary, S.S.S.C under High Court of Punjab and Haryana, Chandigarh on payment of fee of Rs. 500/- per answer sheet (in the shape of Indian Postal Orders payable in favour of S.S.S.C.) within thirty days from the date of declaration of final result on the official website of S.S.S.C. No separate request in this regard by any candidate or any other person on their behalf shall be entertained under the RTI Act for re-evaluation/re-checking etc.
