ENGAGEMENT OF APPRENTICES FOR FY 2026-27- DECLARATION OF FINAL RESULT

Attention is drawn to our notification dated 11.06.2026, where applications were invited from the eligible candidates for the engagement of Apprentices under the Apprentices Act, 1961 for the financial year 2026-27.

Subsequent to the conduct of the online test on July 5, 2026, we are pleased to declare the list of provisionally shortlisted candidates to be engaged as Apprentices under the Apprentices Act, 1961 for the Financial Year 2026-27.

The list of provisionally shortlisted candidates for Engagement of Apprentices is attached as **Annexure I**.

The address and point of contact at Regional Offices is attached as **Annexure II**.

All provisionally shortlisted candidates are advised to report to the allotted Regional Office as mentioned in Annexure I against their roll no for document verification and completion of further formalities related to engagement. **The date of reporting shall be from July 30, 2026, and July 31, 2026, at allotted Regional Offices.** The apprenticeship program shall commence from August 1, 2026.

It is advised to carry original as well as photocopy of KYC documents (PAN, Aadhar, Passport, Driving License etc.), original call letter for document verification and all other relevant documents i.e. certificate of educational qualification, work experience / NOC from current employer, caste certificate/ disability certificate if applicable, medical fitness certificate, and any other document required as per Bank's notification dated 11.06.2026 along with 4 passport size colour photographs, while reporting to the allotted Regional Office for verification by the Bank official.

It is once again advised to check if provisionally shortlisted candidates are fulfilling eligibility criteria as per notification dated 11.06.2026 in all respects. Bank reserves the right to disqualify any candidate who does not fulfill the eligibility criteria at any point of time.

All announcements/addendum/ corrigendum/ details pertaining to this process will be only published / provided on authorized Bank's website www.centralbank.bank.in from time to time under Recruitment section.

Candidates are advised to regularly visit the Bank's website for updates/ notices/ instructions.
